# CONFLICT OF INTEREST IN THE CANADIAN ACADEMY

### History

- The allure of purity, the limits to unworldliness, and the paradox of the freedom to be disciplined
- Plato's Academy (and its groves), then Scholium, Religious Foundation (Bologna, Oxford, Paris, Salamanca, etc.), Research Institution (von Humboldt), Ivory Tower (Sainte-Beuve), Treasonous Place (Benda, Goebbels, Stalin), Public Utility (Clark Kerr), Business (James Keller), Bastion of Democracy (ask any authoritarian)
- Interests (and duties) always in play and in conflict: external and internal, individual and collective, material and not, in private as well as public universities contending with nepotism, doctrine (and its enforcers), bribery and corruption, and self-censorship

### Tendency

Scrupulous self-recusal is the dominant tendency in peer review and collegial governance: no great problem there The growing problems lie with the managed university: donors as owners, and brand management before academic integrity ■ To hype or to hide? That is the question? And why are some academic (and student and community) leaders demonized as ringleaders while others are welcomed as **cheerleaders**?



## Remedy

- Regulate to educate, not to suffocate
- Confidentiality is not designed to hide conflict of interest or over-protect commercial interests
- Avoid the Chatham House Rule as a pretext for excessive redaction (see the Monsanto Affair 2015)
- Not cracks in concealment where the light gets in, but maximum transparency and collegial oversight in the institutional, academic, and public interest
- Avoid the unproductive optics of damage control (Giesy/3M) and the chill expressing risk aversion

#### Recommendation

- A review of CoI policies and practices at the U of S initiated by Senate but including tri-cameral representation, and an external authority; (I recommend Arthur Shafer of the U of Manitoba)
- In this way, Senate shows a double allegiance to institutional reputation and academic integrity, while aptly reversing the flow of influence from University Council and the Board of Governors; Senators hence show initiative, and demonstrate once more that you care too
